Contest for Research Scholarship for Graduates - 1 vacancy

13 August 2021

A call for tenders is open for one Bachelor Scholarship within the scope of the project Knowledge Academy OUT-TO-IN, financed by national funds through Calouste Gulbenkian Foundation, under the following conditions:

Scientific area: Human Kinetics

Admission requirements:

Bachelor degree in Psychomotor Rehabilitation with proven experience in the promotion of children's development, their socio-emotional competence through body and expressive mediation techniques, as well as in the context of adult stress management, through body mediation techniques. Experience in scientific dissemination will also be a preferred factor.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

- Preparation and planning of mind-body intervention programs for children and for educators/teachers;
- Implementation, evaluation and monitoring of a body-mind intervention program for preschool children and for educators/teachers;
- Organization of the database;

- Data analysis;
- Participation in training actions;
- Participating in the communication and dissemination of the project.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019 <https://www.fct.pt/apoios/bolsas/regulamento.phtml> and other applicable rules.

Place of work: The work will be developed at Sports and Health Department of the University of Évora, under the scientific guidance of the Professor Guida Veiga.

Duration of the scholarship(s): The scholarship will have a duration of 10 months, starting on october of 2021. The scholarship contract may be renewed until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €835,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<http://fct.pt/apoios/bolsas/valores>), payments being made monthly, by check or bank transfer.

Selection methods: The selection will be based on the curriculum evaluation with the following weighting for the preferred factors: (i) 50% - Experience in body-mind intervention programs with children and adults in an educational context; (ii) 25% - Knowledge and competences in the scope of body-mind interventions and socio-emotional competence; (iii) 25% - Experience in research projects in the scientific area of the scholarship, especially in data collection and database organization. If justified, the jury may request an interview with the candidates.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade posted in a visible and public place of the Sports and Health Department of the University of Évora. The candidate approved will be notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 18 to 31st August of 2021 and the results of the selection will be published by 10 of September of 2021.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications, and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
