1 scholarship for a graduate enrolled in a master's degree

The 22 september of 2021

A call for tenders is open for one Scholarship(s) for a graduate enrolled in a master's degree within the scope of the project APPRAIS - governance, quality, accountability: a Piloting Reform Process in kurdistAn region of Iraq, financed by ERASMUS + Program Ka2 Capacity Building in the field of higher education (KA203), Grant agreement number 618781-EPP-1-2020-1-IT-EPPKA2-CBHE-SP, under the following conditions:

Scientific area: Design

Admission requirements: Degree and frequency of master's degree in Communication Design and Development of specific content in the area of Entrepreneurship, Innovation and Knowledge Transfer is a requirement.

The candidate must have a good level of English, written and spoken. Leadership skills, good interpersonal skills, strong initiative, dynamism and creativity will be considered as preferential factors. Technical and digital skills will also be valued, as well as other professional experiences that are relevant to the tasks to be performed.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan: The selected candidate will be responsible for:

- 1. Management and promotion of ERASMUS+ APPRAIS project activities;
- 2. Support for the participation of the University of Évora in the ERASMUS+ APPRAIS project;





- 3. Creation and management of content in the field of design and communication;
- 4. Support for the activities if the Innovation, Cooperation, Entrepreneurship and Employability Division.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019 https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt and other applicable rules.

Place of work: The work will be developed at Innovation, Cooperation, Entrepreneurship and Employability Division of the University of Évora, under the guidance of the Professor Soumodip Sarkar.

Duration of the scholarship: The scholarship will have a duration of 6 (six) months, starting on October 2021. The scholarship contract can be extended for periods of 6 (six) months until the end of the project or until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €835,98 according to the table of scholarships awarded directly by FCT, I.P. in Portugal (http://fct.pt/apoios/bolsas/valores), payments being made monthly, by check or bank transfer.

Selection methods: Selection will be based on merit, experience and availability of candidates in accordance with admission requirements (50%). A selection interview will be held for the first five candidates (50%). The jury reserves the right not to select any candidate if the submitted applications do not fulfil the requested profile.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list alphabetically, by final grade obtained or otherwise posted in a visible and public





place (at the rectory of the University of Évora) being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 24 September to 8 October 2021 and the results of the selection will be published by 11 October of 2021.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Letter of interest, Curriculum Vitae, certificate of qualifications, reference or recommendation letters and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
