**Scholarship HIBA 2**

A call for tender is open for (1) Scholarship (Master's, MSc) within the scope of the project "0762\_HIBA\_6\_E" financed by European funds through the INTERREG POCTEP Program via the European Regional Development Fund (ERDF), under the following conditions

**Scientific area:** Agronomy Eng. or related

**Admission requirements:** i) Master's degree; ii) Specific and/or professional training in Agricultural Engineering and/or related areas; iii) Preference is given to those with professional experience in precision agriculture; iv) Preference is given to those with training in Geotechnologies (GIS, DR, GNSS); v) Preference is given to those with experience in training activities.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for **"BI" (Research Grants)** must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

**Workplan:** the workplan is included in some tasks of the project, namely:

Management of the project activities under the Demo Lab in new technologies in Agriculture; Management and Maintenance of infrastructures associated with the project; Field data collection and data management; Training activities under the Demo Lab to be created under the project. Support to laboratory work and all field work when necessary. Preparation of project monitoring reports.

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder,

as set in the template [https://www.fct.pt/apoios/Minuta\\_Contrato\\_Bolsa.docx](https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx), pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt> and other applicable rules.

**Place of work:** The work will be developed at MED - Mediterranean Institute for Agriculture, Environment and Development of the University of Évora, under the scientific guidance of Professor José Rafael Marques da Silva.

**Duration of the scholarship:** The scholarship will have a duration of 12 months, starting January, 2022. The scholarship contract can be renewed until the end of the budget allocation of the funded project.

**Amount of monthly maintenance allowance:** The amount of the scholarship corresponds to € 1 104.64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<http://fct.pt/apoios/bolsas/valores>), payments being made monthly, by check or bank transfer.

**Selection methods:** The selection methods to be used will be the following:

- 1) Curriculum evaluation (50%);
- 2) Motivation letter (20%)
- 3) Interview (30%) if necessary or in case of a tie;
- 4) If the interview is not considered necessary, the curricular assessment will have a weight of 80%.

**Advertising/notification of results:** The final results of the evaluation will be publicised, through a list ordered by final classification obtained or other, posted in a visible and public place of the Department of Rural Engineering. The approved candidate will be notified by e-mail.

To ensure the right of prior hearing of interested parties, the final classification will be announced by any written means to all interested parties.

After communicating the provisional list of results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications:** The tender is open from November 09 to November 23, 2021 and the results of the selection will be published by November 30, 2021.

Applications must be formalized, obligatorily, by sending an application letter explicitly identifying the **HIBA 2 scholarship** with the following documents: Curriculum Vitae, certificate of qualifications, letters of reference or recommendation, motivation letter and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a statement of honor signed by the candidate, but failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, implies the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
