MSc. Fellowship - 2 positions

December 10, 2021

A call for tenders is open for two MSc. Scholarships within the scope of the project **ICAPP**-Investigação em carnes alentejanas de porco preto, reference **POCI-01-0247-FEDER-072109**, cofinanced by European Regional Development Fund (ERDF) through COMPETE 2020 — Competitiveness Factors Operational Program, under the following conditions:

**Scientific area**: Food Science and Technology, Biochemistry, Biological Sciences, Agronomic Sciences, or related areas.

**Admission requirements**: Master's degree, knowledge in the fields of chromatography, biochemistry, microbiology, rheology, and statistical data processing. Laboratory experience is required, with work carried out in the fields of chromatography, biochemistry, microbiology, and rheology. The candidate should also have a driving licence (own car is desirable), high sense of responsibility, high capacity of organisation at work, team spirit, dynamism, autonomy and motivation.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

## Work plan:

Among other tasks the persons to be hired will have to:

- 1) Conduct physicochemical analyses, including chromatographic and rheological analyses;
- 2) Perform microbiological analyses;

- 3) Conduct sensory evaluations;
- 4) To organise tests, data, methodologies, etc;
- 5) To carry out statistical processing of data;
- To write reports and scientific articles.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template <a href="https://www.fct.pt/apoios/Minuta\_Contrato\_Bolsa.docx">https://www.fct.pt/apoios/Minuta\_Contrato\_Bolsa.docx</a>, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <a href="https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt">https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt</a> and other applicable rules.

**Place of work**: The work will be developed at Universidade de Évora, Núcleo da Mitra, under the scientific guidance of the Professor Miguel Nuno Geraldo Viegas dos Santos Elias.

**Duration of the scholarships:** The scholarship will have a duration of six months, starting on January 2022. The scholarship contract may be renewed until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1.104,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="http://fct.pt/apoios/bolsas/valores">http://fct.pt/apoios/bolsas/valores</a>), payments being made monthly, by check or bank transfer.

**Selection methods**: The selection of candidates will be made through a curriculum evaluation. If necessary, an interview may be held with the candidate(s) with the best classification in the curricular assessment.

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list *by final grade obtained* posted in a visible and public place nearby MED — Mediterranean Institute for Agriculture, Environment and Development at the University of Évora, the approved candidate being notified through *email*.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications**: The tender is open from December 13 to December 27, 2021 and the results of the selection will be published by December 30, 2021.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications, and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honour signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
