

CIDEHUS - Interdisciplinary Centre for History, Culture and Societies Contest for Research Scholarship for Graduates - 1 vacancy

14 of January of 2022

A call for tenders is open for one Bachelor Scholarship within the scope of the project PISTA - Partilha de Informação sobre Sustentabilidade do Turismo no Alentejo, (ALT20-03-0246-FEDER-000059), financed by national funds through PO Alentejo 2020 and co-financed by European Regional Development Fund (ERDF), under the following conditions:

Scientific area: Tourism

Admission requirements:

The scholarship is for Graduates. Candidates must have a Degree in Tourism (preferential factor) and be enrolled in a cycle of studies leading to the attribution of academic degrees or a non-degree awarding course (eliminatory factor); average degree equal to or greater than 14 values (eliminatory factor); experience in supporting the organization of knowledge dissemination events in tourism (preferential factor); experience of institutional representation in events in tourism (preferential factor); institutional communication experience on social platforms/networks (preferential factor); proven experience in writing institutional communication materials (preferential factor); proven experience in writing technical-scientific reports in tourism and/or sustainable tourism (preferential factor); knowledge of the Alentejo territory (preferential factor); interest in teamwork and research in sustainable tourism; and availability to travel in the territory corresponding to the Alentejo NUT II.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan: The scholarship will involve the development of several activities associated with the project, mainly the following activities: 1) operationalization of the link between regional tourism agents; 2) preparation of reports and operational tasks associated with the adequacy of instruments for disseminating knowledge/results to the various actors; 3) tasks related to monitoring the technological platform made available to regional tourism agents; and 4)

preparation of the participation in dissemination events and the logistics associated with these events, as well as their follow-up.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt and other applicable rules.

Place of work: The work will be developed at CIDEHUS and Colégio do Espírito Santo - CES of the University of Évora, under the scientific guidance of the Professor Jaime Serra.

Duration of the scholarship: The scholarship will have a duration of 7 months, starting priveuly on March of 2022. The scholarship contract may be renewed until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €805,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (http://fct.pt/apoios/bolsas/valores), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be based on the following parameters: Curriculum evaluation (100%).

The jury may call the candidates for a selection interview if considered necessary or in the event of a tie. In this case the selection interview will have the evaluation of 50% and the curriculum will have the evaluation of 50%.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place at CIDEHUS – Palácio do Vimioso, being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 17th to 31th January of 2022 and the results of the selection will be published by February 4 of 2022.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae and certificate of qualifications.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
