## Research grant for master enrolled in doctorate

(1 position)

January 7th 2022

A call for tenders is open for one Scholarship for a master enrolled in doctorate degree within the scope of the project TETRIS — Technology Transfer Innovation Schemes in Latin America, with the reference 618597-EPP-1-2020-1-PT-EPPKA2-CBHE-JP from University of Évora, though DIC2E, financed by European Commission - ERASMUS +, under the following conditions:

Scientific area: Management, Economics or similar areas

**Admission requirements**: Master degree in Economic Sciences or similar areas, experience in the areas of innovation and entrepreneurship and Doctoral application are mandatory requirements.

Knowledge regarding the proposing institution will also be valued. The candidate must have a very good level of English written and spoken. Knowledge of other languages will be valued. Good interpersonal relationships, strong initiative and dynamism will be considered as preferential factors. Other professional experiences that are relevant to the tasks to be performed will also be valued.

**Work plan**: The selected candidate will be responsible for:

- 1. Management and promotion of ERASMUS+ TETRIS project activities;
- 2. Support for the development of training and matchmaking activities with national and international companies;
- 3. Develop activity reports, based on indicators previously agreed
- 4. Support the general activities of the Innovation, Cooperation, Entrepreneurship and Employability Division of the University of Évora.

**Applicable legislation and regulations**: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template <a href="https://www.fct.pt/apoios/Minuta">https://www.fct.pt/apoios/Minuta</a> Contrato Bolsa.docx, pursuant to the



Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt and other applicable rules.

**Place of work**: The work will be developed at Innovation, Cooperation, Entrepreneurship and Employability Division of the University of Évora, under the guidance of the Doutor Carlos Godinho.

**Duration of the scholarship:** The scholarship will have a duration of 6 (six) months, starting on February of 2022. The scholarship contract can be extended for periods of 6 (six) months until the end of the project.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1.104,64 according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="http://fct.pt/apoios/bolsas/valores">http://fct.pt/apoios/bolsas/valores</a>), payments being made monthly, by check or bank transfer.

**Selection methods**: Selection will be based on merit, experience and availability of candidates in accordance with admission requirements (70%). A selection interview will be held for the first five candidates (30%). The jury reserves the right not to select any candidate if the submitted applications do not fulfil the requested profile.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list alphabetically, by final grade obtained or otherwise posted in a visible and public place (at the rectory of the University of Évora) being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications**: The tender is open from 7 to 28 of January of 2022 and the results of the selection will be published until January 31 of 2022.

Applications must be formalized, obligatorily, by sending the following documents:



Letter of interest

Curriculum Vitae

References of up to 5 projects in which the candidate has participated and which he considers most relevant in his professional training

Certificate of qualifications, reference or recommendation letters and other supporting documents considered relevant

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
