

## Department of Informatics NOVA Laboratory for Computer Science and Informatics (NOVA-LINCS) Research Scholarship for Master degree- 1 position

21 of July of 2022

A call for tenders is open for 1 Research Scholarship for Master degree within the scope of the project 'Entity and Property Inference for Semantic Archives (EPISA)', DSAIPA/DS/0023/2018 financed by national funds through FCT/MCTES and co-financed by European Regional Development Fund (ERDF) through COMPETE — Competitiveness Factors Operational Program (POFC), under the following conditions:

Scientific area: Informatics

## Admission requirements:

- Master Degree in Computer Science or similar
- Frequency of a PhD course in Computer Science or similar
- Knowledge of Database Technologies, Relational Model
- Understanding of the Portuguese language, written and spoken
- Knowledge of Natural Language Processing Tools and OWL Ontologies / Graph-oriented
   Databases, as a preferred factor

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

## Work plan:

 Creation of information extraction processes from the ISAD(G) elements with free text description into CIDOC-CRM representations of the events and entities described in the text. These processes must be accomplished by defining an OWL ontology, which

- represents the information to be extracted, to be used in the pragmatic interpretation of the Portuguese sentences.
- 2. Development of a prototype to evaluate the data migration process between a relational database with the ISAD(G) model and an owl/graph-oriented database ontology that implements a CIDOC-CRM ontology.
- 3. Prepare a final report in which the experience is described.
- 4. Participate in the writing of a scientific article for submission to a scientific conference.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template <a href="https://www.fct.pt/apoios/Minuta\_Contrato\_Bolsa.docx">https://www.fct.pt/apoios/Minuta\_Contrato\_Bolsa.docx</a>, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <a href="https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt">https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt</a> and other applicable rules.

**Place of work**: The work will be developed at Research Centre NOVA LINCS of the University of Évora, under the scientific guidance of the Profs. Irene Pimenta Rodrigues and Dora Melo.

**Duration of the scholarship:** The scholarship will have a duration of 3 months, starting on September of 2022. The scholarship contract may be renewed up to (ex.) a maximum of 6 months or until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to € 1104,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (http://fct.pt/apoios/bolsas/valores), payments being made monthly, by check or bank transfer.

**Selection methods**: The selection methods to be used will be the following:

- Curriculum evaluation (50%)
- Adequacy of training to the work plan (20%)
- Interview (30%)

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an alphabetically ordered list posted in a visible and public place Department of Informatics of University of Évora, being the candidates approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications**: The tender is open from 25 of July to 5 of August of 2022 and the results of the selection will be published by 15 of August of 2022.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
