



**CIDEHUS – Centro Interdisciplinar de História, Culturas e Sociedades da
Universidade de Évora - Project UIDP/00057/2020
Research scholarship for Graduate student – 1 vacancy**

16th of August of 2022

A call for tenders is open for one Graduate Research Scholarship(s) within the scope of the project CIDEHUS – Centro Interdisciplinar de História, Culturas e Sociedades da Universidade de Évora, Projeto UIDP/00057/2020, financed by national funds through: FCT/MCTES – OE, under the following conditions:

Scientific area: Tourism

Admission requirements: The scholarship is for Graduates. Candidates must have a Degree in Tourism or Languages and Literatures (Languages and Tourism profile) (preferential factor) and be enrolled in a cycle of studies leading to the attribution of academic degrees or a non-degree awarding course (eliminary factor); average degree equal to or greater than 12 values (eliminary factor); experience in the process of design and application of questionnaires to visitors (preferential factor); knowledge of the Alentejo territory (preferential factor); interest in teamwork and research in sustainable tourism; and experience working with the SPSS software and with qualitative data analysis (preferential factor).

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for “**BI**” (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan: The applicants should perform several activities associated with the project, mainly the following tasks: a) design and operationalization of questionnaires to the Alentejo’s visitors (online and personal administration); b) administration of questionnaires to the Alentejo’s visitors; c) collection of information, from several different sources, regarding tourism, heritage and culture in the Alentejo region; d) literature review on themes related to the project; e) organization, systematization and analysis of the information and data collected; f) collaboration in the preparation of 2 reports; g) collaboration in the preparation of articles for publication; h) other tasks related to the PACTUAL project.

The research activity will be developed within the framework of the internal project PACTUAL – “Património Cultural e Turismo no Alentejo: motivações e experiências do visitante português”

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt> and other applicable rules.

Place of work: The work will be developed at Centro Interdisciplinar de História, Cultura e Sociedades da Universidade de Évora and Colégio do Espírito Santo, in the city of Évora, under the scientific guidance of Prof.^a Noémi Marujo.

Duration of the scholarship(s): The scholarship will have a duration of 6 months, starting on October 2022. The scholarship contract may be renewed up to 6 months.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €875,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<http://fct.pt/apoios/bolsas/valores>), payments being made monthly, by check or bank transfer.

Selection methods: The selection method to be used will be based on the following parameters: Curriculum evaluation (100%).

The jury may call the candidates for a selection interview if considered necessary or in the event of a tie. In this case the selection interview will have the evaluation of 50% and the curriculum will have the evaluation of 50%.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list, by final grade obtained posted in a visible and public place at Palácio do Vimioso, being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 25th August to 7th September of 2022 and the results of the selection will be published by 16th September of 2022.

Applications must be formalized, obligatorily, by sending an application letter with the following documents:

- a) Curriculum Vitae
- b) Graduation certification
- c) Motivation Letter
- d) Other documents considered relevant for the application process.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
