Call for tenders for Research scholarship for Graduate – 1 vacancy Project VILUS

27 December 2022

There is an open call for applications for one Graduate Research Grant in the scope of CIDEHUS - Interdisciplinary Center of History, Cultures and Societies of the University of Évora, for the Internal **project VILUS** - Wine from Southern Lusitania: cross analysis on containers, contents, storage, and trade - UIDB/00057/2020, financed by national funds through FCT/MCTES, under the following conditions:

Scientific area: History and Archaeology

Admission requirements: Degree in Archaeology, or History and Archaeology, or Cultural Heritage and Archaeology, or similar; and be enrolled in a cycle of studies leading to a degree or non-degree course (eliminatory factor); basic knowledge of Roman archaeology (preferential factor); proven experience in the study of archaeological materials, preferably pottery (preferential factor); proven experience in the preparation of inventories of archaeological materials and management of databases (preferential factor); basic knowledge of archaeological drawing (preferential factor); interest in teamwork and research in the area of archaeology and archaeometry; availability to carry out studies of ceramic materials in different regions of Southern Portugal, especially in Alentejo (preferential factor); good written and oral expression skills.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

1) Survey of bibliographical data on the Roman occupation of Southern Portugal and wine production in *Lusitania*;

2) Study of collections of Roman ceramic materials (amphorae, dolia and common ware) from museum deposits and archaeological sites in Southern Portugal; among which the municipal archaeological deposits of Alcácer do Sal, Ponte de Sor, Fronteira and Sines; the deposit of archaeological materials from the archaeological site of Mirobriga (Santiago do Cacém); and the Museu Regional de Beja and the Museu Nacional de Arqueologia (Lisbon);

3) Inventory of ceramic materials, typological classification and drawing of pottery;

4) Interpretation of the data collected, together with the project team: study of archaeological contexts, quantification and statistical analysis of the pottery assemblages studied;

4) Support in the elaboration of communications, publications and scientific articles in the scope of the project results;

5) Production of dissemination materials, both written and audio-visual, of the project activities;6) Collaboration in the organisation of events.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt and other applicable rules.

Place of work: The work will be developed at CIDEHUS-University of Évora, and in other places necessary for the collection of information and study of archaeological materials, under the scientific supervision of Doctor Sónia Bombico.

Duration of the scholarship(s): The scholarship will have a duration of (6) six months, starting on March of 2023. The scholarship contract may be renewed up to a maximum of 6 (six) months.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to € 875,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (http://fct.pt/apoios/bolsas/valores), payments being made monthly, by check or bank transfer.

Selection methods:

- Curricular assessment 70%
- Interview in Portuguese language -30 %

In "1 -Curriculum Assessment" the assessment and scoring will be as follows:

- Academic Qualifications Degree average = 20 points (on a scale of 1 to 20).
- Experience in the study of ceramic archaeological materials = 15 points (on a scale of 1 to 15)
- Knowledge of archaeological drawing (pottery) = 10 points (on a scale of 1-10)
- Knowledge of database and inventories = 10 points (on a scale of 1-10)
- Knowledge of Excel = 10 points (scale of 1-10)
- Knowledge of languages = 5 points (scale of 0-5)

In "2 - Interview in Portuguese language" will be considered:

- Motivation = 10 points (on a scale of 1-10)
- Basic knowledge of Roman Archaeology = 5 points (scale of 0-5)
- Experience in the study of ceramic archaeological materials = 5 points (scale of 0-5)
- Experience on archaeological drawing = 5 points (scale of 0-5)
- Experience with databases and use of Excel = 5 points (scale of 0-5)

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade obtained, posted in a visible and public place, at Palácio do Vimioso, being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from <u>06 January to 27</u> January of 2023 and the results of the selection will be published by <u>10 February of 2023</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents:

- Motivation Letter (1 A4 page)
- Curriculum Vitae;
- Certificate of qualifications;
- Proof of enrolment or registration in a study cycle or course not leading to a degree;
- Other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
