RESEARCH SCHOLARSHIP FOR BACHELOR'S DEGREE - 1 VACANCY

A call for tenders is open for 1 *one* Scholarship(s) for Bachelor's Degree within the scope of the project the History of Science, Technology and Environment project - by IHC – UE, Ref^a UIDB/04209/2020, Funded by the Science and Technology Foundation Technology (FCT)/MCTES - OE, under the following conditions:

Scientific area: History of Science and Technology

Admission requirements:

- Hold a Bachelor's Degree in Engineering and training in the History of Science; Fluent written and spoken knowledge of English
- Ability to integrate into an interdisciplinary work group
- Preferential factor attending a Doctoral Program in the area of History of Science, with a registered thesis project

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

The work plan, to be developed in the HCTA Research Group of the IHC – UE hub, will consist of the following achievements:

• Research agenda in the History of Science and Technology – networks and knowledge transfer.



- Innovative research within the research agenda connected with the History of Transport and Mobility, in a vision of the social construction of technology within the scope of studies of the history of science, technology and society, in a transnational context of the 20th century, shaping the history of science and technology and science diplomacy.
 - Required outputs:
 - a) Promotion of two internal HCTA research seminars.
 - b) Participation in Scientific Congresses, with peer review
 - c) Preparation and submission of two articles in international journals indexed by Scopus

Applicable legislation and regulations:

The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://files.dre.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

Place of work:

The work will be developed at Palacio Vimioso - IHC of the University of Évora, Research Group HCTA, under the scientific supervision of the PhD Quintino Lopes, CEEC FCT Researcher

Duration of the scholarship(s):

The scholarship will last for 6 months, starting in April 2023. The scholarship contract may be renewed until the end of the budget allocation for the financing project.

Amount of monthly maintenance allowance:

The amount of the scholarship corresponds to €930,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM_2023.pdf), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following:

Curriculum evaluation - 70%:

- a) Academic Training (30%);
- b) Professional CV (45%);
- c) Scientific and pedagogical activity in a Higher Education Institution, participation in projects, publications, consultancy and dissemination of knowledge and letter of motivation (25%)

Interview - 30%

Demonstration of ability to execute the objectives of the work plan of the Announcement and dynamism of work for the HCTA Research Group.

Advertising/notification of results: The final results of the evaluation will be publicized through an alphabetically ordered list, by final grade obtained or otherwise posted in a visible and public place – Palácio Vimioso – Universidade de Évora, being the candidate (a) approved notified through an oficial email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 28th of February to 14th of March of 2023 and the results of the selection will be published by 17th of March 2023.

Applications must be formalized, mandatory, by sending an application letter and a letter of motivation accompanied by the following documents: Curriculum Vitae, qualifications certificate, a reference or recommendation letter and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honour signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrolment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th. The presentation of the certificate is mandatory for the signing of the contract.
