Research scholarship for Bachelor's Degree - 1 vacancy

16 of March 2023

A call for tenders is open for 1 Scholarship for Bachelor's Degree under the financing contract called "EIT Health RIS Hub", co-financed by European Commission under the following conditions:

Scientific area: Management, economics, information and communication technologies, Health or similar areas will be considered.

Admission requirements:

- a) Bachelor's degree in a compatible scientific área;
- b) Candidate must be enrolled in master's degree;
- c) Very good level of english written and spoken, duly proven. Knowledge of other languages will be valued;
- d) Experience in organizing events and teamwork;
- e) Good interpersonal relationship, strong initiative, dynamism and availability to travel abroad, will be taken into account as preferential factors;
- f) Other professional experiences that are relevant to the tasks to be performed will also be valued.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan: The selected candidatate will be responsible for:

- 1. Management and promotion of EIT Health activities;
- 2. Support for the preparation of applications within the scope of innovation and entrepreneurship in the health area;
- 3. Support for coordinating the participation of the University of Évora in EIT Health;
- Support for DIC2E activities.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of



August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://files.dre.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

Place of work: The work will be carried out at the Innovation, Cooperation, Entrepreneurship and Employability Division of the University of Évora, under the scientific guidance of Doctor Carlos Godinho.

Duration of the fellowship: The fellowship will be last for 6 months, starting on April of 2023 and may be extended until the end of the project.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €930,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM 2023.pdf), payments being made monthly, by check or bank transfer.

Selection methods: selection will be based on merit, experience and availability of candidates in accordance with admission requirements (60%). A selection interview will be held for the first five candidates (40%). The jury reserves the right not to select any candidate if the submitted applications do not meet the requested profile.

Composition of the selection jury:

President: Professor Paulo Quaresma; 1st member: Doctor Carlos Godinho; 2nd member: Doctor Hernâni Oliveira;

1st substitute member: Doctor Lúcia Rosado; 2nd substitute member: Professor Célia Antunes.

Form of publication/notification of results: The final results of the evaluation will be published, through an ordered list, by the final grade obtained or another posted in a visible and public place at the Rectory of the University of Évora, with the approved candidate being notified by email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and form of submission of applications: The tender is open from $\underline{27^{th}}$ of March to $\underline{10^{th}}$ of April of 2023 and the selection results will be published by $\underline{14^{th}}$ of April of 2023. Applications must be formalized, obligatorily, by sending an application letter accompanied by the following documents:

- 1. letter of motivation from the candidate;
- 2. two letters of professional recommendation;
- 3. Curriculum Vitae;
- 4. references of up to five projects in which the candidate participated and which he considers most relevant in his professional training;



5. certificate of qualifications and other supporting documents deemed relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
