A call for tenders is open for one Scholarship BI graduated, within the scope of the project *INT-ACT Intangible Cultural Heritage, Bridging the Past, Present, and Future* (101132719), co-financed by European Commission and UKRI through Program HORIZON-CL2-2023-HERITAGE-01-04, under the following conditions:

**Scientific area:** Archeology or related area

**Admission requirements:**

Graduated in History/Archaeology or related fields. Preferably the candidate should have research experience, in information search in History and/or Archaeology, in computer programming, 3D modelling and Geographic Information Systems.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for “BI” (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

**Work plan:**

The work will require activities in order to

- Work cooperatively with the interdisciplinary INT-ACT team
- Study the cultural heritage cases related to the project
- Study the CIDOC CRM model
- Adapt models for the context of INT-ACT Project
- Write reports that constitute deliverables of the INT-ACT Project
- Write papers reporting the research made in the context of INT-ACT Project

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template [former.fct.pt/apoios/Minuta\\_Contrato\\_Bolsa.docx](https://former.fct.pt/apoios/Minuta_Contrato_Bolsa.docx), pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16,

**Place of work:** The work will be developed at CIDEHUS, University of Évora, under the scientific guidance of the Doctor Renata Vieira.

**Duration of the scholarship(s):** The scholarship will have a duration of 6 months, starting on April of 2024. The scholarship contract may be renewed until the end of the funding project's budget allocation.

**Amount of monthly maintenance allowance:** The amount of the scholarship corresponds to €930,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal ([https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM\\_2023.pdf](https://www.fct.pt/wp-content/uploads/2023/02/Tabela-de-Valores-SMM_2023.pdf)), payments being made monthly, by check or bank transfer.

**Selection methods:** The selection methods to be used will be the following: curriculum evaluation and interview, with the respective valuation of 60% and 40%.

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place at CIDEHUS, being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications:** The tender is open from 19 of January to 20 of February of 2024 and the results of the selection will be published by 12 of March of 2024.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications, reference or recommendation letter, motivation letter.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.
