Scientific Research Initiation Scholarship (BII) – 2 Vacancies

January 17, 2024

A competition is open for the award of two Scientific Initiation Scholarships within the scope of the «African Experiences project. Freedom, Colonialism and Poetry in Cruzeiro Seixas»», financed by national funds through the Center for Art History and Artistic Research (CHAIA), with the reference UIDB/00112/2020, under the following conditions:

Scientific Area: (1) Architecture / (2) Multimedia

Admission requirements:

- (1) Attendance of the Integrated Master in Architecture;
- (2) Graduate in Fine Arts, pre-Bologna, with teaching experience in Multimedia.

According to the FCT Research Grants Regulation No. 950/2019 of December 16, 2019, article 5, — BII (Research Initiation Grants) cannot be awarded to anyone who has already benefited from research grants directly or indirectly financed by FCT, awarded under the terms of the Research Fellow Statute.

Work plan:

Grant (1) – Collaboration in the definition of spaces and assembly of the exhibition "Experiências d'Áfricas", namely with the design, creation and assembly of models and dioramas, in the space of the National Library of Portugal (Lisbon), evocative of the exhibitions of Surrealists in Lisbon (1949), Cinema Restauração -Luanda (1953) and "Palácio dos Fantasmas" (1957) and the ethnographic collection.

Scholarship (2) – Collaboration in defining spaces and assembly of the exhibition "Experiências d'Áfricas", namely in the production of replicas of pieces/sculptures by Cruzeiros Seixas that were present at the Surrealists exhibitions in Lisbon (1949), at Cinema Restauração -Luanda (1953) and at "Palácio dos Fantasmas" (1957), as well as his ethnographic collection.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out through the signing of a contract between the University of Évora and the scholarship holder as per draft former.fct.pt/apoios/Minuta Contrato Bolsa.docx under the terms of the Research Scholarship Holder Statute (Law No. 40/2004 of August 18th and Decree-Law No. 123/2019 of August 28th) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, I.P in force, regulation No. 950/2019 of December 16, 2019:

Workplace: The work will be developed at CHAIA at the University of Évora, under the scientific guidance of Professors Jorge Alberto Croce Rivera and Vítor Manuel dos Santos Gomes.

Duration of the scholarship(s): The scholarship will last six months, starting on March, 2024. The scholarship contract may be renewed for a maximum of 2 months or until the end of the project's budget allocation of financing.

Value of the monthly maintenance subsidy: The amount of the scholarship corresponds to €601.12, according to the table of scholarship values awarded directly by FCT, I.P. in the country (https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf), with payments made monthly, via check or bank transfer.

Selection methods:

"The selection methods to be used will be the following: curricular evaluation (100%). If deemed necessary by the jury, for additional clarification or for tiebreaker purposes, the first two candidates for each scholarship may be called for an interview. In the case of using an interview, the evaluation elements will be valued as follows: curricular evaluation (85%); interview (15%).

Composition of the Selection Jury:

Method of publishing/notifying results: The final results of the assessment will be published, through an alphabetically ordered list, by final grade obtained or another posted in a visible and public place at CHAIA, with the approved candidate being notified through email.

Under the terms of the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of evaluation results, candidates have a period of 10 working days to, if they wish, make their comments at a prior hearing of interested parties.

Application deadline and form of submission of applications: The competition is open from <u>February 21</u>, 2024 to March 6, 2024 and the selection results will be published by March 11, 2024.

Applications must be formalized by sending an application letter accompanied by the following documents: Curriculum Vitae and other supporting documents considered relevant.

For application purposes, proof may be replaced by a declaration of honor from the candidate, but failure to demonstrate, during the contracting phase, possession of the degree required by the application deadline or failure to present proof of enrollment or registration in a cycle of studies or non-degree-awarding course, for scholarships with this component, imply the cancellation of the candidate's evaluation.









Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law n° . 66/2018, of August 16 and Ordinance no. 33/2019, of January 25th. Presentation of the certificate is mandatory for signing the contract.
