SCHOLARSHIP FOR BACHELOR'S DEGREEE HOLDERS - 1 vacancy

25 March 2024

A call for tenders is open for one Bachelor's Degree Scholarship within the scope of the project "Holy Bodies | An Atlas of the corpi santi in Portugal" (2022.01486.PTDC), financed by the Foundation for Science and Technology, I.P./MCTES through national funds, under the following conditions

Scientific area: Architecture, Design

Admission requirements: Graduation in Architectural Culture or Design without the possibility of replacing the qualification with professional training or experience. Proven skills in 3D modelling, explicitly using Maya, Sketchup, Unreal Engine, Blender or Rhino software and expertise in developing virtual spaces. Proficiency in Portuguese and English.

As set forth in FCT Research Scholarship Regulation No. 950/2019 of 16 December 2019, articles 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

- 1. Participation in in-situ campaigns for 3D digitisation of relics (*corpi santi*) and associated heritage assets and collection of 360° photographs of the spaces where they are located;
- 2. Research and characterisation of web-based platforms for creating and presenting virtual exhibitions;
- 3. Definition of a museographic narrative and creation of a web-based virtual reality space, respective exhibition equipment, lighting design and sound environments for displaying the relics (*corpi santi*) and complementary information.







The work must be completed within six months.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf other and applicable rules.

Place of work: The scholarship holder will work under the scientific supervision of Professor Jorge de Sá and Dr Leonel Alegre and will be hosted by the HERCULES Laboratory at the University of Évora. The workplace will be the _ARTERIA_LAB at the Colégio dos Leões — University of Évora.

Duration of the scholarship(s): The scholarship will last 6 months and is scheduled to start on October of 2024.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €990.98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following:

The Curricular Assessment (CA) aims to analyse the candidates' qualifications, namely: proven experience in 3D modelling using Maya, Sketchup, Unreal Engine, Blender or Rhino software (A); proven experience in designing and developing virtual spaces (B); skills in interactive design (C). Experience in these areas must be proven by submitting a portfolio. The curricular assessment also includes motivation to participate in the project by submitting a letter of motivation (D).

The weighting for the **CA** is 100 per cent. It will be expressed on a scale of 0 to 20, with the classification obtained by the arithmetic mean of the classifications of the elements to be assessed, according to the following formula:

- **A.** Proven experience in 3D modelling using Maya, Sketchup, Unreal Engine, Blender or Rhino software: 40%;
- B. Proven experience in designing and developing virtual spaces: 30%.
- C. Skills in interactive design: 20%
- **D.** Motivation letter: 10%

AC = A*0,4 + B*0,3 + C*0,2 + D*0,1







If necessary, the selection board reserves the right to call up to three candidates for an interview **(E)**. Candidates who score less than 9.5 will be excluded from the procedure.

The Interview (E) will be graded on a scale of 0 to 20 and will last no more than 20 minutes.

The **Final Classification (CF)** of the candidates called for interview is expressed on a scale of 0 to 20 as a result of the following arithmetic average:

CF = 70% AC + 30% E

If candidates fail to turn up, they have withdrawn from the competition. The jury may not award the grant if no candidate is found with the profile considered suitable.

Advertising/notification of results: The final evaluation results will be publicised through a final grade-ordered list posted in a visible and public place in the HERCULES Laboratory, and the winning candidate will be notified by email.

The Final Classification list will be announced by any written means to all interested parties to ensure the right to a prior hearing of the interested parties. After communicating the provisional list of the evaluation results, candidates have 10 working days to express their opinions in a preliminary hearing of interested parties.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced to all interested parties by any written means. After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from $\underline{2}$ of April to $\underline{17}$ of May of 2024, and the selection results will be published by $\underline{29}$ of May of 2024.

Applications must be formalised, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, portfolio, qualification certificate, motivation letter and other supporting documents deemed relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of







proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of 16 August and Ordinance No. 33/2019, of 25 January.

SECOND CLAUSE

In the alternative, the FCT Research Grant Regulations apply, of which the Second Party declares that it is aware.

THIRD CLAUSE

The Second Party undertakes to carry out the attached work plan, the content of which he/she declares that he/she has taken full cognisance of and accepts unreservedly, from the above-mentioned start date and on an exclusive dedication basis, under the terms of article 5th of the Research Fellow Statute.







FOURTH CLAUSE

FIFTH CLAUSE

SIXTH CLAUSE
The First Party may cancel the grant and the Second Party may be obliged to refund all or part of the sums received in the following cases:
 a) Serious and repeated failure to comply with the Second Party's obligations under the Research Grant Holder Statute and the FCT Research Grant Regulations, for reasons attributable to the Second Party;
 b) A negative evaluation of the Second Grantor's performance by the supervisor or the host organisation under the terms of the FCT Research Grant Regulations; c) False declarations by the Second Granting Party on matters relevant to the award and renewal of the grant or to the assessment of its development.
SEVENTH CLAUSE
Without prejudice to the provisions of the previous clause, this contract shall terminate automatically:
 a) Upon completion of the activity plan; b) End of the period for which the scholarship is awarded; c) Repeated non-compliance by one of the parties; d) Revocation by mutual agreement; e) Establishment of a legal employment relationship with the host organisation.
EIGHTH CLAUSE
1. The rights and duties of the parties are those resulting from the provisions of the Research Fellow Statute.
2. The Second Party declares that he/she has read the Research Fellow Statute and the applicable Regulation(s) and undertakes to comply with their provisions.
NINTH CLAUSE
It is agreed between the parties, that in case of need and to settle all questions arising from this contract, the District Court of (name of the District) shall have jurisdiction, expressly waiving any other.







TENTH CLAUSE

Any changes to be made to the contract in the course of its performance shall be the subject of prior written agreement.

ELEVENTH CLAUSE

- 1. This contract shall take effect on the date it is signed by both parties.
- 2. The grant awarded under the terms of the FIRST CLAUSE of this contract may be renewed for additional periods of (...) months, up to a maximum of (...) months, under the terms of article 15 of the FCT Scholarship Regulations.
- 3. [ONLY FOR RESEARCH SCHOLARSHIPS, otherwise withdraw]: The award of the academic degree (or diploma) during the term of this contract shall not affect its effects, and the grant referred to in the preceding paragraph may be renewed at a later date, provided that it is aimed at carrying out activities that are indispensable for the completion of the project (...).
- 4. The concrete definition of the activities referred to in the previous paragraph is the responsibility of the First Party, after hearing the Second Party and the Scientific Advisor, and they must be included in the agreement to be signed, as provided for in the previous clause.
