Scientific area: Agricultural Sciences or related

### Admission requirements:

Master's degree in Agricultural Sciences or related.

Laboratory research experience with molecular technologies, endpoint and quantitative PCR.

Experience in diseases plant diagnostic and identification.

Experience in genetic sequence analysis.

Experience in New Generation Sequencing, analysis of metagenomics and RNA seq results.

Knowledge in Xlora plataform and Baco equipment use.

To have at least 4 published papers in the last 3 years.


As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

### Work plan:

The Work Plan for this research fellowship consists of:

- 1 –Extraction of DNA and RNA from microorganisms.
- 2 Evaluation, quantification and analysis of nucleic acids.
- 3 PCR amplification with SybrGreen, Taqman and Lamp technologies.
- 4 Bioinformatic analysis of sequences.
- 5 Statistical analysis of the results.
- 6 Utilization of the equipemnts MiNION, Dr. Vida and Baco
- 7 Writing of articles for dissemination of the results obtained







Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP nº950/2019 in force. regulation of December 16. 2019: https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

**Place of work**: The work will be developed at Laboratory of Plant Virology of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor, Maria do Rosário Félix, who must draw up an opinion on the final activity report of the scholarship (**Annex II**), according to the draft in **Annex III**.

**Duration of the scholarship(s):** The scholarship will have a duration of 12 months, starting on May of 2024. The scholarship contract may be renewed up to until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1259,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf">https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf</a>), payments being made monthly, by check or bank transfer.

**Selection methods**: The selection methods to be used will be the following: - Curriculum evaluation, Interview and Research experience in Plant Pathology, with the respective valuation of 30%, 40% and 30%.

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list alphabetically posted in a visible and public place MED, being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications**: The tender is open from <u>18 of April to 3</u> of May of 2024 and the results of the selection will be published by <u>07 of May of 2024</u>.







Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificates of qualifications, two recommendation letters and one motivation letter.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
