Palliative Care (ENF12823M)

Attitudes towards death: life trajectory, the end of life and death

Palliative Care: philosophy, values and principles, evolution, organizational models

Ethical issues related to the end of life.

Communication: skills and strategies of interpersonal communication; Communication of bad news / conspiracy of silence / dealing with uncertainty / management of hope. Self-care of professionals

General principles in symptom control. Prevalent symptoms. Evaluation and management of pain and human suffering, use of standardized instruments. Non-pharmacological strategies used to alleviate physical and psychological suffering.

Family Needs: socio-family assessment; APGAR Family; Genogram and ecomap; Family conference;

Management care for the family / caregiver, including psychological and spiritual care. Caregiver training.

Management and comfort care in the last days and hours of life.

Process of mourning: normal, anticipatory / preparatory, complicated.
