3. Program description:

The Master of Music Teaching of the University of Évora aims at providing the skills and superior knowledge in the area of Music Education in order to permit, either the access to the labor market in the education field (specialist music training), or the access to higher education programs related to the 3rd cycle. In addition, it aims to generate social functioning skills of insight, learning and autonomous work, individually and collectively, and the development of personal and interpersonal skills that enable the exercise of a highly specialized career. The Master of Music Teaching degree provides a specialization dedicated to specialist music teaching, according to the pertaining legislation (legislative decree 220/2009 and 79/2014). It is offered, potentially, in the the following specialization areas: Flute; Oboe (inactive in 2020-21); Clarinet; Saxophone; Bassoon; French horn; Trumpet; Trombone; Tuba; Percussion; Violin; Viola (inactive in 2020-21); Cello; Double bass (inactive in 2020-21); Piano; Classical Guitar; Accordion; Portuguese Guitar (inactive in 2020-21); Drums (inactive in 2020-21); Voice; Composition.

9. General conditions of access and admission:

i Legal conditions for access to the cycle of studies leading to the master degree

The following individuals can apply for a cycle of studies leading to the master degree:

- holders of a Portuguese Licenciado degree or legal equivalent;
- holders of a foreign higher education undergraduate degree, which is recognized as satisfying the objectives of the degree of Licenciado by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum which is recognized as attesting the ability to carry out this cycle of studies by the competent scientific committee of the higher education institution where they wish to be admitted.

ii **Conditions of access to the cycle of studies at the University of Evora**

On the application date, the undergraduate students must satisfy conditions that guarantee the conclusion of their undergraduate degree until the 30th of October of the admission year. The admission and enrollment of these students is conditioned on the conclusion of the degree until this date, and the enrollment is canceled if the student does not complete the degree within that period.

During the first application phase, students who have a maximum of 6 curricular units or 36 ECTS missing for conclusion of their degree can apply for the 2nd cycle; in the 2nd application phase students can apply if they have at most 3 curricular units missing and in the 3rd application phase if they have at most one curricular unit missing.

The previous condition does not apply to students with a curriculum that reveals professional or scientific experience, which can be recognized by the competent scientific body, as attesting the student's ability to carry out the master's degree/post-graduation, provided that the student required that recognition in the application process.

iii **Specific admission conditions**

Holders of a higher academic qualification in the area of music, with 120 credits in Instrumental and Vocal Practice, in Music Education and in Musical Sciences and none with less than 25 credits, as specified in DL 79/2014 of May 14 .

Furthermore, the access to this cycle of studies requires:

1. The oral and written domain of the Portuguese language and the domain of the essential rules of logical argumentation (c.f. Article 17 of Decree-Law 79/2014 of May 14). This condition will be certified by the combination of a written test of Portuguese language with an interview. In both, the candidate must obtain approval. This is compulsory for all, regardless of previous training or professional status. The application can also be made by presenting a certificate of approval in both components, issued by another higher education institution, less than two years ago, considering the conditions set forth in Decree-Law 79/2014 of May 14. This written test and interview will take place on April 3 (1st phase) and July 10 (2nd phase) 2020, in a place and time to be announced.
2. The approval in an interview, comprising specific access exam (instrument / voice / composition); both the oral component of the interview and the specific access exam (instrument / voice / composition) are eliminatory, and candidates are excluded if they do not obtain approval on any one of them. The dates of the interview and specific access exam (instrument / voice / composition), will be as follows: March 31, April 1 and 2 (1st phase); July 7, 8 and 9 (2nd phase) 2020, at a time to be announced, at Mateus d'Aranda College.

- Academic qualifications: 15%
 - Area of qualifications: 10%
 - Average grade in the highest qualification: 60%
 - Level of qualifications: 30%
- Curriculum analysis: 15%
 - Artistic Experience or Portfolio / Artistic Dossier in the area of the program: 20%
 - Professional Training in the area of the program or related fields: 40%
 - Professional Experience in the area of the program or related fields: 20%
 - Teaching experience in training programs in the area of the program: 20%
- Interview: 70%

- Specific vocational aptitude: 75%
- Understanding the objectives and professional exits of the program: 5%
- Availability: 10%
- Motivation and commitment: 10%

Observations regarding the selection process:

The interview includes a practical test (instrument / voice / composition) designed to assess specific vocational aptitude. In this test, candidates (instrument /voice) must be prepared to present a repertoire of their choice, of a total duration not exceeding 20 minutes, including contrasting genres and styles (the jury reserves the right to hear all or part of the program presented). Composition candidates must present two original works of their own.

This interview, including the practical instrument / voice / composition test, should not be confused with the oral and written Portuguese test.
