### 3. ERASMUS MUNDUS program:

a. **Organization of the program:** 1st semester- University of Paris 1 Pantheon-Sorbonne

2nd semester - University of Padova

3rd semester - University of Evora

4th semester - the students are distributed by the three universities indicated above, according the university to which belongs the dissertation supervisor.

Between the 3rd and 4th semester students take a period of mobility at one of the Mobility Partner Universities: University of Alicante (Spain); Faculty of Letters and Human Sciences of Sfax (Tunisia); Polytechnic University of Prague (Czech Republic) and Federal University of Technology Paraná (Brazil).

b. **Applications (place, ranking process, announcement of results):** Applications and selection of students with EU EACEA grants are carried out according to the European Union calendar.

Applicants with other scholarships or without scholarships also apply to the University coordinating the program and the application deadline is the beginning of September 2020.

### 4. Program description:

Betting on internationalization, on mobility and on the answer to global world challenges, the Master Erasmus Mundus + TPTI: Techniques, heritage, industrial landscapes is an international master course regrouping nine universities: Paris1 Panthéon-Sorbonne, Évora, Padova, Alicante, Prague, Curitiba, Sfax, Oviedo and Puebla and whose academic pathways is done in Évora, Paris and Padova universities. This training aims to improving knowledge on Cultural Heritage, particularly Technical, Industrial and Landscape Heritage, passing by historical analysis and land analysis, the research and management, the research-action and heritage enhancement. Ensured by teachers from different countries, with experience in the scientific fields of this training, provides for students different visions about Cultural Heritage with geographic and cultural settings very diversified, seeking to form experts

capable to safeguard and manage the Cultural Heritage and thinking the Heritage as a sustained development way and as a cultural promotion of different regions and countries. Students are prepared to a professional career through internships, the learning of different languages and the mobility in different European and non-European countries. At University of Évora, this master is presented as an area of specialization of the master Management and Enhancement of Historical and Cultural Heritage.

## 10. General conditions of access and admission:

### i Legal conditions for access to the cycle of studies leading to the master degree

The following individuals can apply for a cycle of studies leading to the master degree:

- holders of a Portuguese Licenciado degree or legal equivalent;
- holders of a foreign higher education undergraduate degree, which is recognized as satisfying the objectives of the degree of Licenciado by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum which is recognized as attesting the ability to carry out this cycle of studies by the competent scientific committee of the higher education institution where they wish to be admitted.

### ii Specific admission conditions

The evaluation criteria of applications are defined by the master Erasmus Mundus + TPTI: Techniques, Heritage, and Industrial Landscape consortium. Evaluation of applications is done by the Master Scientific Committee (CSLM) members, composed of representatives from the different universities of the consortium, at a defined date according to the European Union – Erasmus Mundus + program time-limits.
