3. Program description:

This Master's course aims at providing the students with sound and authoritative knowledge and the ability to actively develop such knowledge in the areas of native and non-native languages and linguistics, based on previously acquired skills and instruction and seeking to broaden and improve knowledge. The study cycle aims at developing skills which allow the students to acquire academic specialization through research and innovation activities to strengthen their professional competences. They will acquire skills to be applied in problem solving in novel and unfamiliar situations in extended and multidisciplinary contexts thus contributing to increase knowledge of pragmatic, cultural social and ethical nature. The study cycle also aims at promoting an integrative perspective of knowledge, articulating and intersecting a diversified area of learning which can be found in the two branches and meet the interest of the clientele for multidisciplinary practices which may lead to research such as in the areas of terminology and terminography, phraseology and praseography, document organization, computing applied to translation (namely, dictionaries), tradutology, linguistic consultancy in Portuguese and European public and private institutions, education (in Portugal, Europe and Portuguese-speaking countries), through the publishing of materials for the teaching of Portuguese as a native and non-native language.

Area of specialization in Translation: support or accompaniment of translation materials, revision, edition and / or dissemination in Portuguese language of international scientific and literary production; support or follow-up of the production of didactic-pedagogical materials to support the translator; research in translation / writing / revision / terminology; (in national and Community bodies as well as in companies).

Area of specialization in Language Sciences: teaching / education (in its various levels); investigation; professional qualification; language consultancy (in national and Community bodies as well as in companies); culture industries; edition of texts (in the press, publishers and libraries).

9. General conditions of access and admission:

i Legal conditions for access to the cycle of studies leading to the master degree

The following individuals can apply for a cycle of studies leading to the master degree:

- holders of a Portuguese Licenciado degree or legal equivalent;
- holders of a foreign higher education undergraduate degree, which is recognized as satisfying the objectives of the degree of Licenciado by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum which is recognized as attesting the ability to carry out this cycle of studies by the competent scientific committee of the higher education institution where they wish to be admitted.

ii Conditions of access to the cycle of studies at the University of Evora

On the application date, the undergraduate students must satisfy conditions that guarantee the conclusion of their undergraduate degree until the 30th of October of the admission year. The admission and enrollment of these students is conditioned on the conclusion of the degree until this date, and the enrollment is canceled if the student does not complete the degree within that period.

During the first application phase, students who have a maximum of 6 curricular units or 36 ECTS missing for conclusion of their degree can apply for the 2nd cycle; in the 2nd application phase students can apply if they have at most 3 curricular units missing and in the 3rd application phase if they have at most one curricular unit missing.

The previous condition does not apply to students with a curriculum that reveals professional or scientific experience, which can be recognized by the competent scientific body, as attesting the student's ability to carry out the master's degree/post-graduation, provided that the student required that recognition in the application process.

iii **Specific admission conditions**

- a) Holders of 1st cycle degree from Portuguese universities organized under the principles of the Bologna Process in the study area 22 – Humanities – and its areas of education and training as provided in the Decree nº 256/2005 of March 16 (CNAEF), as well as graduates in other areas of study and their areas of education and training as provided in the same decree (e.g. 14, 31, 34) or in other groups, such as nos. 4, 7, or 8;
- b) Graduates in Pre-Bologna Licenciante courses, from Portuguese or foreign universities, in the same areas described in a) or legally equivalent;
- c) Graduates in courses not described in the decree mentioned in a) but which are considered relevant by the competent Scientific Council of the University of Évora;
- d) Holders of similar courses from foreign universities organized under the principles of the Bologna Process;
- e) Holders of foreign higher education degrees which are recognized as satisfactorily meeting the requirements of a 1st cycle degree by the competent Scientific Council of the University of Évora;
- f) Holders of academically, scientifically and professionally relevant curricula which are recognized as satisfactorily meeting the requirements of a 1st cycle degree by the competent Scientific Council of the University of Évora.

- Academic qualifications: 50%
 - Area of qualifications: 40%
 - Average grade in the highest qualification: 40%
 - Level of qualifications: 20%
- Curriculum analysis: 50%
 - Scientific and technical activities and publications: 20%
 - Participation in research projects: 20%
 - Professional Experience in the area of the program or related fields: 20%
 - Professional Training in the area of the program or related fields: 20%
 - Participation in conferences and similar activities: 10%
 - Training in transversal competences: 10%

11. Maximum number of admissions

- Maximum number of admissions for candidates with nationality of European Union countries: 10
- Maximum number of admissions for candidates without nationality of countries of the European Union: 8

Depending on the number of applications, there may be transfer of vacancies from the international students applications to the European Union students applications or vice-versa.

12. Minimum number of students: 8

13. Tuition fee

- Candidates with nationality of European Union countries: 1050.00 €
- Candidates without nationality of countries of the European Union: 2500.00 €
 - Annual Tuition fee for international students with merit scholarship: 1050.00 €
 - Annual Tuition fee for international students with cooperation and development scholarship: 1250.00 €

All students with international student status who have an undergraduate degree grade which is equal to or higher than 15 (in a scale of 0-20), will have a reduced tuition fee in the first year of the program due to the merit scholarship. To maintain this reduced tuition fee in the following years, the student has to pass all curricular units and have an average grade equal or above the minimum merit grade. All students with international student status from PALOP countries, will have a reduced tuition fee in the first year of the program due to the cooperation and development scholarship. To maintain this reduced tuition fee in the remaining years the student has obtain a minimum academic performance.
