# 3. Program description:

PIUDHIST is an inter-university doctoral programme in which History is viewed from an inter-disciplinary point of view. In our vision, this is also why we consider apposite to attach, as a subtitle for this programme, the words "change and continuity in a global world". As such PIUDHist is a result of formal cooperation between four Portuguese universities:

- § Universidade de Lisboa Instituto de Ciências Sociais and Faculdade de Letras
- § ISCTE-Instituto Universitário de Lisboa Departamento de História
- § Universidade Católica Portuguesa Centro de Estudos de História Religiosa (Faculdade de Teologia) e Faculdade de Ciências Humanas
- § Universidade de Évora Instituto de Investigação e Formação Avançada

The taught component of the program will take up most of the students' time during the first two semesters. The course is organized into four basic thematic axes, of which students will choose two:

- § Social dynamics and political structures
- § Institutions and economic development
- § Empires, colonialism and post-colonialism
- § Intellectual and socio-cultural movements

Students enjoy the greatest freedom in their choice of thesis topic and of thematic seminars. Guidance

# i Legal conditions for access to the cycle of studies leading to the «Doutor» degree (Ph.D. degree)

The following individuals can apply for a cycle of studies to the «Doutor» degree (Ph.D. degree):

- holders of a Portuguese Mestre degree (Master degree) or legal equivalent;;
- holders of an undergraduate degree holding a specially relevant academic or scientific curriculum, which is recognized as attesting capacity to carry out this cycle by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum that is recognized as attesting the
  ability to carry out this cycle of studies by the competent scientific committee of the higher
  education institution where they wish to be admitted.

#### ii Specific admission conditions

The following are admitted as candidates for registration:

- a) holders of a master's degree or legal equivalent in the area of History or any other area of Social and Human Sciences, giving preference to candidates with experience in historical research.
- b) Exceptionally, holders of a bachelor's degree or legal equivalent, provided that they have a particularly relevant school or scientific curriculum and that they present letters of recommendation that demonstrate their ability to carry out this cycle of doctoral studies.
