3. Program description:

The PhD Program in Human Kinetics at the University of ?vora aims to promote the development of research skills in the scientific domain of Human Kinetics (HK). This cycle of studies has as its general objective to provide a specialized response in the fundamental domains of HK, in terms of research in health education, physical activity and health, sports performance, psychomotricity and sports management. It is also intended to strengthen the relationship with the business community and the surrounding community, allowing the transfer of knowledge to the socioeconomic fabric, placing the application of science and technology at the service of economic development and the well-being of the populations. In terms of specific objectives, it is intended that students develop competencies, skills and research methods in HK: be able to carry out original research works that contribute to the expansion of knowledge and that justify national or international dissemination in publications with a selection committee; develop communication skills in the field of HK with peers, the rest of the academic and scientific community and society in general; enter the labor market with high knowledge and skills within the scope of HK; promote, in an academic and or professional context, technological, social or cultural progress, in a knowledge-based society.

Fundamental and applied research within the scope of Human Kinetics; Insertion in national and international public or private organizations in the field of human kinetics; Consultancy and entrepreneurship in the areas of health education, physical exercise and health, sports performance, sports management and psychomotricity; Teaching in university and polytechnic institutions.

8. General conditions of access and admission:

i Legal conditions for access to the cycle of studies leading to the «Doutor» degree (Ph.D. degree)

The following individuals can apply for a cycle of studies to the «Doutor» degree (Ph.D. degree):

- holders of a Portuguese Mestre degree (Master degree) or legal equivalent;;
- holders of an undergraduate degree holding a specially relevant academic or scientific curriculum, which is recognized as attesting capacity to carry out this cycle by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum that is recognized as attesting the
 ability to carry out this cycle of studies by the competent scientific committee of the higher
 education institution where they wish to be admitted.

Depending on the number of applications, there may be transfer of vacancies from the international students applications to the European Union students applications or vice-versa.

11. Tuition fee

- Candidates with nationality of European Union countries: 1500.00 €
- Candidates without nationality of countries of the European Union: 2500.00 €
 - Annual Tuition fee for international students with merit scholarship: 1500.00 €
 - Annual Tuition fee for international students with cooperation and development scholarship:
 1700.00 €

In the admission year, all students with international student status who have a grade C higher or equal to 16 (C= 0.6 x undergraduate average + 0.4x masters average, both averages on the scale 0-20), benefit from the tuition fee for international students with merit scholarship and all students from PALOP countries benefit from the tuition fee for international students with cooperation and development scholarship. In the following years, to keep the merit or cooperation and development scholarship, the student has to meet the conditions stipulated in article 22 of the Academic Regulations of the University of Évora and the results are published until October 31 of each academic year, without the need to apply for the scholarship
