# 3. Program description:

The Master of Science in Economics study program aims essentially at providing a solid theoretical and pratical knowledge in Economics that allow the graduates to enhance their prospects of employability as well as to open new perspectives for specialization and further study in third cycles.

The program?s structure is more focused in the area of Economic Analysis. It aims at providing students with general and specific skills in economics, encouraging research and the progression to the third cycle through a strong articulation with the Doctoral Program in Economics. Many faculty members are part of CEFAGE-UE - the research center in economics and management of the University of ?vora- which is also a strong foundation for research and quality assurance in teaching / research teaching.

Nevertheless, according to the regulations, it also provides the possibility for the students, who wish to carry out more applied work, to complete the degree by a traineeship or project report.

Thus, the Master's Degree in Economics allows to conciliate theory and practice in a strand of excellence and enhancing the employability of master's students in more applied activities of daily life, or by providing training that allows graduates to pursue advanced research studies in the area of economics.

The graduates will be able to carry out advanced functions in international, national and regional organizations, in companies, and also to pursue a research career in their areas of expertise. This can be done in National Authorities such as AdC,ANACOM, commercial and investment banking and central banks (BdP, ECB), and other regional entities (City Councils) or local authorities.

#### 8. General conditions of access and admission:

# i Legal conditions for access to the cycle of studies leading to the master degree The following individuals can apply for a cycle of studies leading to the master degree:

- holders of a Portuguese Licenciado degree or legal equivalent;
- holders of a foreign higher education undergraduate degree, which is recognized as satisfying
  the objectives of the degree of Licenciado by the competent scientific committee of the higher
  education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum which is recognized as attesting
  the ability to carry out this cycle of studies by the competent scientific committee of the higher
  education institution where they wish to be admitted.

#### ii Conditions of access to the cycle of studies at the University of Evora

On the application date, the undergraduate students must satisfy conditions that guarantee the conclusion of their undergraduate degree until the 30th of October of the admission year. The admission and enrollment of these students is conditioned on the conclusion of the degree until this date, and the enrollment is canceled if the student does not complete the degree within that period.

During the first application phase, students who have a maximum of 6 curricular units or 36 ECTS missing for conclusion of their degree can apply for the 2nd cycle; in the 2nd application phase students can apply if they have at most 3 curricular units missing and in the 3rd application phase if they have at most one curricular unit missing.

The previous condition does not apply to students with a curriculum that reveals professional or scientific experience, which can be recognized by the competent scientific body, as attesting the student's ability to carry out the master's degree/post-graduation, provided that the student required that recognition in the application process.

#### iii Specific admission conditions

The holders of an undergraduate degree in Economics or other compatible or suitable scientific area may apply for the Master in Economics.

In any case candidates may be admitted, although they do not have the basic training in economics, they may, given their potential, be admitted, and the Executive and Supervisory Board will be able to decide on the compulsory frequency of a unit Basic curriculum - Fundamentals of Economics, in order to level basic knowledge at the outset.

• Academic qualifications: 50%

- Training in Mathematics: 30%

- Area of qualifications: 25%

- Average grade in the highest qualification: 30%

- Level of qualifications: 15%

• Interview: 50%

- Specific vocational aptitude: 20%

Ability to understand: 20%Ability to Communicate: 20%Knowledge of English: 20%

- Availability: 20%

# Observations regarding the selection process:

The applicants that do not attend the interview will be automatically excluded from the admission procedure. It will be also excluded from the admission procedure the applicants whose grade in the interview is less than 12 - fair (scale from 0 to 20).

#### 10. Maximum number of admissions

- Maximum number of admissions for candidates with nationality of European Union countries: 15
- Maximum number of admissions for candidates without nationality of countries of the European Union: 10

Depending on the number of applications, there may be transfer of vacancies from the international students applications to the European Union students applications or vice-versa.

In the admission year, all students with international student status who have an undergraduate average of 15 or above (on a 0-20 scale) benefit from the international student merit scholarship tuition fee and all students from PALOP countries benefit from the tuition fee for international students with cooperation and development scholarship. In the following years, to keep the merit or cooperation and development scholarship, the student has to meet the conditions stipulated in article 22 of the Academic Regulations of the University of Évora and the results are published until October 31 of each academic year, without the need to apply for the scholarship
