3. ERASMUS MUNDUS program:

- a. **Organization of the program:** 1st semester- University of Paris 1 Pantheon-Sorbonne
 2nd semester - University of Padova
 3rd semester - University of Evora
 4th semester - the students are distributed by the three universities indicated above, according to the university to which belongs the dissertation supervisor.
 Between the 3rd and 4th semester students take a period of mobility at one of the Mobility Partner Universities: Polytechnic University of Prague, University of Oviedo, University of Sfax, University Cheikh Anta Diop of Dakar, University of Kagoshima, University of Córdoba
- b. **Applications (place, ranking process, announcement of results):** Université Paris 1 Phantéon-Sorbonne, and evaluated by the CSLM of the Masters in which are representatives of the various universities of the Consortium. The University of Évora is represented by Prof^s Ana Cardoso de Matos and Ant^onia Fialho Conde. The management of the master is done by the representatives of the consortium (CSLM) who meet face to face at least twice a year.

4. Program description:

Betting on internationalization, on mobility and on the answer to global world challenges, the Master Erasmus Mundus +? TPTI: Techniques, heritage, industrial landscapes is an international master course regrouping nine universities: Paris1 Panthéon-Sorbonne, Évora, Padova, Alicante, Prague, Curitiba, Sfax, Oviedo and Puebla and whose academic pathways is done in Évora, Paris and Padova universities. This training aims to improving knowledge on Cultural Heritage, particularly Technical, Industrial and Landscape Heritage, passing by historical analysis and land analysis, the research and management, the research-action and heritage enhancement. Ensured by teachers from different countries, with experience in the scientific fields of this training, provides for students different visions about Cultural Heritage with geographic and cultural settings very diversified, seeking to form experts

capable to safeguard and manage the Cultural Heritage and thinking the Heritage as a sustained development way and as a cultural promotion of different regions and countries. Students are prepared to a professional career through internships, the learning of different languages and the mobility in different European and non-European countries. At University of Évora, this master is presented as an area of specialization of the master Management and Enhancement of Historical and Cultural Heritage.

i Legal conditions for access to the cycle of studies leading to the master degree

The following individuals can apply for a cycle of studies leading to the master degree:

- holders of a foreign higher education undergraduate degree, which is recognized as satisfying the objectives of the degree of Licenciado by the competent scientific committee of the higher education institution where they wish to be admitted;
- holders of an academic, scientific or professional curriculum which is recognized as attesting the ability to carry out this cycle of studies by the competent scientific committee of the higher education institution where they wish to be admitted.

ii Specific admission conditions

The evaluation criteria of applications are defined by the master Erasmus Mundus + TPTI: Techniques, Heritage, and Industrial Landscape consortium. Evaluation of applications is done by the Master Scientific Committee (CSLM) members, composed of representatives from the different universities of the consortium, at a defined date according to the European Union ? Erasmus Mundus + program time-limits.

The evaluation criteria for applications are defined by the Erasmus Mundus + TPTI Master: Technical, Heritage, and Industrial Landscape Consortium. The evaluation of the applications is done by the Master Scientific Committee Members (CSLM), composed by representatives of the universities of the consortium, on a date defined by the European Union (Erasmus Mundus+)
